



SEASON PASS APPLICATION

Beginning the first business day of January, the Allegan County Parks and Recreation Commission will begin selling season passes for the current year. Season Passes provide the park user with access to all county owned or managed parks and boat launches, and also allows for horse trail access (day riding & overnight horse trail fees) at Silver Creek County Park, Ely Lake County Campground and Pine Point County Campground. **Passes DO NOT include camping at any county owned or managed campground.** Season Passes can be purchased by visiting the Parks Office in the Human Services Building, online, mail and telephone. Payment will be required at the time of purchase.

A copy of Allegan County Park Ordinance #1010, Park Rules and Regulations is posted at all park sites. Copies are also available from the Parks Office. Please review the rules and regulations. A pass does not preclude adherence to the park rules.
